STAR RENTAL EQUIPMENT PROTECTION (SEPP)

(The Customer) elects to purchase and pay for the SEPP, The Customer will not be responsible for accidental damage, fire, theft and vandalism (that is substantiated by a police or fire report), except that (a) rubber tire wear; track wear or damage in excess of normal wear and tear (b) damage resulting from upset, overturn or contact with overhead obstructions and (c) damage to electrical devices resulting from a portable electric current (unless the portable electric current is a generator supplied by the Star Rentals Ltd.) is not covered by the SEPP and is the responsibility of the the Customer. The Customer will pay to Star Rentals Ltd. a deductible of 10% of the repair or replacement cost of the equipment to a maximum amount of \$2,000.00 and will also pay the Star Rentals Ltd. the amount of rental rates for each day consumed while equipment is in the process of repair or replacement. The cost of the SEPP is 12% of the rental amount of the equipment. The Repairs provisions of the rental agreement will not apply to the Customer who purchases the SEPP where equipment sustains damage of a nature contemplated by the SEPP. The SEPP does not apply to, and Star Rentals Ltd. does not waive any of its rights or remedies whatsoever against the Company or otherwise for loss of or damage to the equipment that arises out of any use or maintenance of the equipment that is illegal or in violation of Star Rentals Ltd. Rental Agreement. SEPP is not applicable to non owned Star Rentals Ltd equipment. The Customer acknowledges that SEPP is not insurance. By signing in the space provided below the Customer accepts the SEPP and further agrees that any employee or agent for the Company has the authority sign of behalf of the company.
